It is further submitted that till last year this institute was being accorded approval for 120 intake in Electrical Engg and Electronics & Communication Engg. instead of applied intake of 60 each due to which the deficiency was creeping in for last many years. This has been rectified in EoA 2018-2019.

Pantry for Staff/Faculty (Administrative Area)

EXPLANATION: The institute is situated in the surrounded by market and there is a Girls' Hostel in the campus due to which the staff do not feel the lack of pantry facility.

Cafeteria (Amenities Area)

EXPLANATION: The institute is situated in the surrounded by market and geographical location of the Cafeteria/eatables in the market is such that it seems it exists in the campus of the institute. Therefore, students do not feel the lack of cafeteria facility.

Internet Bandwidth, Legal Application S/W, Legal System S/W & PCs to Student ratio (Computational Facilities)

EXPLANATION:

- *a. Internet Bandwidth:* The institute has already a bandwidth of 40 against the required 48 and this deficiency has been met with the free wi-fi provided by JIO Reliance.
